Remarks
 - Algeria uses the combined charge as follows
 MHD calculated from 00.01 AM on the discharge completion day until the day empty container is being returned to the Carrier's terminal A deposit will be requested at time of delivery order submission and will be restituted back to receiver after return of Empty units. Empty containers are to be returned to SATRANS depot. In case empty cntrs are not returned within 90 days after picking up, the value of container (USD 3.500/20 and USD 5.500/40) is to be paid by receiver.

Special containers are Tanks, Reefers, Ventilated, Insulated, Open Top, Hard Top, Bulk, Flats, Platforms.
