**Remarks:**

- Germany has 2 demurrage codes as follows:

- Import Demurrage (DMD) for containers at the Sea terminal. It includes Storages.

Calculation starts at 00.01 the day after vessel discharge until unit gates out full from the Sea terminal.

- Import Inland Terminal Demurrage (IID) for containers at the inland terminal. It applies to Carrier's Haulage in Combined / Multimodal mode of transport. It includes Storages.

Calculation starts at 00.01 the day after delivery of full unit at the inland terminal and expires with dispatchment of full unit.

A crantage fee of EUR 27,50 is charged per each container at the inland terminal for unloading unit from the rail wagon or chassis by crane.

Special containers are Tanks, Reefers, Ventilated, Insulated, Open Top, Hard Top, Bulk, Flats, Platforms.

SOC = Shipper's Own Container - OOG = Out Of Gauge
