A secure app to manage your releases

SCR is a safe and secure online application to get access to your container release information and manage you pickup rights.

Stop using pin codes

Via the Secure Release, your carrier will create a release without using pin codes anymore

Start Transferring

Via the Secure Transfer, you can transfer your container release 100% pin-code-free



Easy

SCR works very similar to the release process you used to have in the past. You don't need any training.

Online

A user friendly application to manage your releases, supporting multiple ports and carriers, providing automated email notifications to receive the latest status info.

Secure


SCR uses state-of-art technology, like blockchain, to make your release process more secure and safe. That's why you need to have an ID wallet, to protect your identity and privacy.

Free

As a Freight Forwarder or Transporter, you can use the SCR web-application free of charge. Other premium services like the SCR API, an ID wallet in the Cloud or premium features come at a cost.

Compliant

With SCR, your container releases are automatically compliant to the new port regulation that regulates a more secure container release process in the Port of Antwerp. The port regulation is in effect since January 1, 2021.



Step <1> Get invited

Ask your carrier or client to receive an invitation to onboard to Secure Container Release. They can send you an invitation request via SCR. You will receive an email to start your onboarding.


Step <2> Onboard your company

During the onboarding process, your general SCR administrator account will be created, the ID Wallet software - needed for additional security - will be installed. You are now ready to start using SCR.

Step <3> Start using SCR

Get access all your releases in SCR via https://app.securecontainerrelease.com
As an SCR administrator, you're ready to create additional user accounts for your colleagues via https://admin.securecontainerrelease.com


Phased roll-out

Both in Antwerp and Rotterdam, SCR is rolled-out using a phased approach.

In phase 1 - the Release between the Carrier & the First Release Party is secured via SCR.

that are already on SCR, can use the Secure Transfer instead of PIN-codes. Now, we are in **phase 2**.

In **phase 3**, we foresee a 100% pincode-free release process*.



^{*} In Antwerp, we foresee a 100% pincode-free release process supported by CPu, via a mobile app or Alfapass, to be confirmed by NxtPort.



ID Wallets

To start using SCR, you first need to install an ID Wallet software. It guarantees superior security and privacy.

An ID wallet allows you to manage your identity yourself, being a real **Self-Sovereign Identity** (SSI) tool.

During the onboarding, a Cloud wallet is installed, allowing you to quickly start using the SCR Web-app. We highly recommend you to migrate to the Company wallet soon.

ID Wallet needed to manage:

- The identity of your organisation
- The connections with your partners



2 types of ID Wallet:

ID wallet In the Cloud

- ID wallet hosted in our cloud
- default option during onboarding, no installation required
- so you can start using the SCR web-app immediately and migrate to an ID Wallet on Premise later
- first 3 months free*

ID Wallet on Premise

- ID wallet installed on premise on your private network or cloud
- for that, you might need intervention from your ICT department - technical documentation is available here.
- recommended for superior security
- free of charge

CPu compliant

Since January 1, 2021 a new port regulation is applicable in the Port of Antwerp, making the container release process more secure.

All your containers released via Secure Container Release are automatically compliant with this new regulation.


